#### **DESCRIPTION**

S&P Tecnogrout-N is a shrinkage compensated grout, formulated on a basis of mineral products and designed for moderate stresses where the use of traditional mortars or concretes is not adequate.

It is supplied ready to use and it is particularly recommended in areas where access is difficult or where concrete placing is not possible, either because a small quantity is required or because the application is unfeasible. S&P Tecnogrout-N is a non-bleeding, self-levelling grout with good chemical resistance (seawater, wastewater, sulphates) that is applied preferably in filling depths between 30 and 80 mm (S&P Tecnogrout-N/PR - 5 to 30 mm; S&P Tecnogrout-N/GR - 80 to 120 mm), except in confined fillings, in which it can be used in any depth.

#### Substrate preparation:

Mechanically abrade concrete surface to completely remove debris and loose particles. Wet the surface until complete saturation is achieved and allow standing water to either evaporate or be absorped into the substrate. Alternatively, remove standing water using a sponge.

#### Mixing:

**APPLICATION** 

Mix the grout either by hand or in a concrete mixer, adding 11.5-13 % of water (2.87-3.25 litres per 25 kg bag). Mix for 4-5 minutes until completely lump-free, ensuring that a homogenous mix is achieved.

#### Application:

The formwork should be sealed to prevent material from leaking and should also be approximately 3 cm higher than the final level of the grout.

Pour from one end until completion of the the filling with the assistance of gravity.

### **Curing:**

Once the grout is installed and 15 minutes have passed, surfaces must be kept damp for at least 24 hours, in order to prevent superficial dehydration of the cement. If located in direct sunlight, the installation must be covered/protected to prevent the grout from curing too quickly.
